

UPON THE DEATH OF AN LBA MEMBER

SURVIVING SPOUSE/DEPENDENT(S) SOC HEALTH AND WELFARE FUND BENEFIT (COBRA)

If you opted to convert the Death Benefit to the Surviving Spouse/Dependent(s) SOC Health and Welfare Fund Benefit, your qualified dependents (defined below) are entitled to receive prescription, optical and dental coverage for <u>three years at no cost</u>, and gives the survivors the added option of continuing the benefits indefinitely for a premium.

Qualified dependents are defined as your spouse, or qualified Domestic Partner, and eligible dependent children. Eligible children include natural children, legally adopted, stepchildren (rules apply) and children for whom you have court appointed guardianship or legal custody and who live with you permanently. For the purpose of the Dental and Optical Benefit, eligible dependent children are covered to the last day of the month of their 19th or up to 23rd birthday (full-time student). For the Prescription Plan, dependent children who were previously enrolled in the Optional Prescription Drug Rider will be covered until December 31st of the year they reach the age of 19 or 23 years (full time student) or until they graduate.

MEDICARE REIMBURSEMENT AFFIDAVIT

Medicare Part B Reimbursement

When the decedent, or one of their dependents, became eligible for Medicare at age 65 (and thereafter) or through special provisions of the Social Security Act for the Disabled, their first level of health benefits was provided by Medicare. In order to maintain maximum health benefits, the decedent (and all retired NYC workers) was mandated to accept Medicare Part A (Hospital Insurance) and Part B (Medical Insurance). If the decedent was receiving a Social Security check, the premium for Medicare Part B was deducted from that check monthly. If the decedent was not receiving a Social Security check, he/she was billed on a quarterly basis by the Social Security Administration. The decedent must have been receiving a City pension check and been enrolled as the contract holder for City health benefits in order to receive reimbursement for Part B premiums.

NOTE: Spouses/Domestic Partners of members whose deaths are directly attributable to an injury/illness related to their receiving an Accident Disability Pension continue to receive the Medicare Reimbursement. This is due to the City continuing to pay for their health insurance at a reduced Medicare rate.

The City of New York reimburses retirees for the monthly premium for Medicare Part B, as well for their eligible dependents on Medicare. The Medicare Part B reimbursement is issued each June for the prior calendar year (January through December; i.e. Medicare reimbursement checks issued in June 2016, reimburse Medicare deductions from 2015). You will only receive the reimbursement for the period of time that the decedent was enrolled in Medicare Part B and covered by a City of New York health plan as a retiree; Medicare Reimbursement ceases with the death of the member. (Retirees who reside outside of the United States are NOT eligible for the Medicare Part B reimbursement since Medicare is not your primary insurer).

In order to receive a "Medicare Reimbursement Affidavit" to claim Medicare reimbursement monies owed to the decedent and, if applicable, their eligible dependent(s) you must notify the Health Benefits Program of the members death, in writing, including the retiree's name, Social Security number, your name, your address, and a copy of the death certificate. Send the request for the affidavit form to the Retiree Health Benefits Section, Affin: Medicare Unit, 40 Rector Street, 3rd Floor, New York, NY 10006. If survivors relocate, they must notify the Retiree Health Benefits Section, Medicare Unit, of the new address to ensure that they receive the reimbursement.

Please be aware that it will take several months for the Retiree Health Benefits Section to forward the reimbursement check, which will be in payment of the previous calendar year, and in some cases a second check will be issued for the months that the retiree was alive in the year of death.

PRE MERGE HOUSING PD / TRANSIT PD ID CARD RENEWAL NEW PROCEDURE FOR HPD AND TPD ID CARDS

There is a new procedure for former members of the HPD and TPD to obtain their retired law enforcement ID card. The cards are still being issued by Transit Bureau but there is no longer a need to appear in person at Transit Bureau HQ in Brooklyn.

At least one month before your card is due to expire (or if your card has already expired) call Housing Bureau at 212 432 2680 or 212 432 2461, or Transit Bureau at 718-610-4660, Inform the PAA that you're calling to obtain a new HPD or TPD ID card. The PAA will ask you a series of questions and ask for a contact telephone number.

About a month later you will receive a call from Transit Bureau ID card section. You will have to email them a copy of your driver's license, your current ID card, and a digital photo of yourself from the waist up in front of a neutral colored background (no hats or sunglasses please).

After processing, a new ID card will be mailed to you via certified mail. If you have any questions, contact Transit Bureau at 718 610 4660 or email them at: TBHQPERSONNEL@NYPD.org.

Note: The Transit Bureau ID card section also issues the HPD ID cards

I suggest the following based on my conversation with the PAA's at the Shield,ID and Uniformed Services Unit aka **ID Card Section**:

- 1. All Ret MOS who want their ID Card renewed call them first to insure their photo is in the new system at 646-610-5150, 646-610-6085, 646-610-6508
- 2. If a Ret MOS has No Expiration Date on the ID Card keep that ID Card.

Cost-of-Living Adjustment

A Cost-of-Living Adjustment (COLA) is a permanent annual increase to your pension, based on the cost-of-living index and a formula set by State law. Once you are eligible, you automatically receive a COLA increase each September.

How COLA is Determined

The law requires COLA payments to be calculated based on 50 percent of the annual rate of inflation, measured at the end of the State fiscal year (March 31). Once you are eligible, your COLA will be at least 1 percent, but no more than 3 percent.

The percentage is applied up to the first \$18,000 of your annual pension benefit as if you had chosen the Single Life Allowance pension payment option, even if you selected a different option at retirement. Using the Single Life Allowance gives you the highest COLA amount possible, since this option pays the highest benefit.

This Year's COLA Increase

The September 2024 COLA is 1.8 percent, for a maximum annual increase of \$324, or \$27 per month before taxes.

The increase you receive each September is added to your existing monthly COLA amount. You can view your benefit payment pay stub to see a breakdown of your pension payment, including your total monthly COLA amount, in your Retirement Online account.

- Sign in to Retirement Online.
- Click "View Pension Check" link.

• Select the date of the pension payment that you want to view.

You will also receive a <u>notification of the net</u> <u>change</u> in your monthly amount by mail at the end of September. It will show both your previous month's and new monthly COLA amount, which represents the total accumulated amount for all the COLA increases you've received since you became eligible. Your 2024 COLA is the difference between Last Month and This Month.

When You'll Be Eligible

To begin receiving COLA payments, you must be:

- Age 62 or older and receiving a service retirement benefit for five or more years; or
- Age 55 or older and receiving a service retirement benefit for ten or more years (applies to uniformed employees such as police officers, firefighters and correction officers who are covered by a special retirement plan that allows for retirement, regardless of age, after 20 or 25 years); or
- Receiving a disability retirement benefit for five or more years; or
- The spouse of a deceased retiree receiving a lifetime benefit under an option elected by the

retiree at retirement (you'll receive half the retiree's COLA amount); or

• A beneficiary receiving the accidental death benefit for five or more years on behalf of a deceased Employees' Retirement System (ERS) member.

Receiving Your First COLA

Your first COLA will be added to the pension payment you receive the month after you become eligible. It will include a pro-rated amount for the month you became eligible. For example, if you become eligible for a COLA in the middle of June, you'll receive your first COLA payment at the end of July, and the payment will be for one and a half months.

NYC pol pushing state bill requiring cops to have personal liability insurance: 'Defund The Police in disguise'



NYC Councilwoman Nantasha Williams is trying to drum up City Council support to back controversial legislation requiring police officers statewide to buy personal liability insurance to hold them more accountable for misconduct - a move the head of the Police Benevolent Association called a veiled attempt by the left to "Defund the Police." Stephen Yang

A Queens Democrat is trying to drum up City Council support for a controversial state bill <u>requiring police</u> <u>officers to buy personal liability insurance in case of lawsuits</u> — a move critics say is a veiled attempt to "Defund the Police."

Councilwoman Nantasha Williams urged other council members this week to back the state legislation, claiming it would save local governments a fortune.

"By shifting the financial responsibility for lawsuit payouts to insurance companies and the officers themselves, local governments can save millions in taxpayer dollars," Williams wrote in an Aug. 7 letter to her fellow council members.

"Additionally, this measure would incentivize improved police conduct, fostering greater accountability within the force," Williams contended, noting she plans to introduce a City Council resolution Wednesday calling on state legislators to pass the bill.

The bill was originally introduced in 2020 by Assemblywoman Alicia Hyndman (D-Queens) and then-Sen. Sen. Alessandra Biaggi (D-Bronx), following the police killing of George Floyd in Minnesota that spurred nationwide riots and now-infamous calls to defund police.

It stalled during that year's legislative session but was re-introduced this year by Hyndman, with Bronx Democrat Nathalia Fernandez replacing Biaggi on the Senate version of the legislation.

The proposed resolution to back the state bill is already getting some pushback in the Big Apple from the Police

Benevolent Association, and both conservative and moderate members of the mostly lefty council. "This bill is an attempt to 'Defund the Police' in disguise," PBA President Patrick Hendry told The Post.

The long-stalled bill was originally introduced in 2020 by then-Sen. Sen. Alessandra Biaggi, a Bronx Democrat, and Assemblywoman Alicia Hyndman (D-Queens) following the police killing of George Floyd in Minnesota that spurred nationwide riots and calls to defund police.

"In our current environment, police officers already face significant civil and criminal liability for simply doing our jobs. The city frequently decides to settle frivolous suits rather than litigating them. Under this bill, those settlements would hit cops in the pocket."

"Requiring already underpaid cops to pay for liability insurance will chase away recruits and drive even more experienced cops towards the exits," Hendry added. "If the City Council really cared about saving money, it would demand that the city start fighting suits against cops instead of settling."

Council Minority Leader Joe Borelli (R-Staten Island) called the measure "an affront to collective bargaining agreements," adding such changes "must be done at the negotiating table because no cop should have to pay for their own insurance."

"On the flipside, maybe private insurance carriers will stop settling on payouts to morons who injure themselves rioting, protesting and assaulting police officers. That is the real problem," added Borelli.

Williams in her letter cited an April report released by Comptroller Brad Lander, an anti-cop socialist running for mayor, showing lawsuits against NYPD cops increased 50% from fiscal year 2022 to fiscal year 2023. The report also said settlement and judgement payouts during the same period rose 12%, from \$239.1 million to \$266.7 million.

"I believe this policy presents a practical and fiscally responsible solution to the escalating costs associated with police misconduct," she said.

The NYPD declined to comment.
